Message from the

World President

This is my second annual report since being elected World President of The Textile Institute in May 2022.

This past year has indeed presented us with a mix of positive and challenging experiences, offering us valuable opportunities to test and refine our skills in navigating various situations. Through these experiences, we have gained resilience, adaptability, and a deeper understanding of our capabilities.

The escalation of conflicts on the international stage poses significant threats to human life, not only in Ukraine and the Middle East. These military actions lead to severe political and economic difficulties worldwide, which, in turn, create problems in regional markets.

The Textile Institute continuously supports its members in these difficult times and encourages them to actively participate in professional events with the aim of sharing knowledge, improving competences and strengthening cooperation.

The biggest TI event in 2023 was the 92nd Textile Institute World Conference, which was held at the University of Huddersfield the 3 to 6 July. The theme of TIWC was: Sustainability of the Textile and Fashion Supply Chain – Transitioning to Zero Carbon and Zero Waste. The conference gathered the representatives of Sections, Council members and delegates, textile experts, industry, and scientists from all over the world. The highlight of TIWC was a speech by HRH The Princess Royal.

In 2023, the Journal of The Textile Institute (JoTI) celebrated its 100th anniversary of publishing research papers. To commemorate this milestone, a special issue of the journal was published and gifted to delegates at the Textile Institute World Conference (TIWC) 2023 in Huddersfield. The Institute's regular activities, including publications such as The Journal of The Textile Institute (JoTI) and Textile Progress, books, professional qualifications and awards, information services, and the organisation of events and short courses for industry, provide valuable services not only to TI members but also to the broader industry.

The Textile Institute is developing a new strategy to define the future direction of its activities. This strategy aims to strengthen the international position of The Textile Institute and enhance its global influence on the exchange of innovative textile knowledge. It focuses on fostering cooperation and advancing sustainable practices within the textile-fashion sector and related industries.

The Textile Institute faced the passing of its Executive Director in early January 2024.

2023 was a year of many changes for The Textile Institute. The Institute welcomed Professor Jess Power CText FTI as the new TI Chair. Jess is a strong and charismatic leader who chairs all meetings substantively and is always well-prepared for her tasks. Her commitment to the matters of The Textile Institute is exemplary.

The Institute will continue to support its members regardless of their geographical location or the challenges they face. Our aim is to foster multidimensional cooperation and contribute to the development of the textile sector.

Chair of Council

I am absolutely delighted to present my first annual report since being elected Chair of The Textile Institute in July 2023 at the 92nd Textile Institute World Conference hosted by the University of Huddersfield. The World Conference was a remarkable event that brought together like-minded individuals to discuss, debate, and share knowledge regarding current and emerging sustainable practices throughout the fashion and textile global supply chain. I had the honour of copresenting the Institute's Awards and Professional Qualifications with Prof Parik Goswami CText FTI (Conference Chair) and Prof Malgorzata Zimniewska CText FTI (Textile Institute World President) at the Ceremony and Gala dinner. At the event Her Royal Highness The Princess Royal highlighted the sustainable challenges within the global industry and urged collaboration between likeminded individuals. The conference was further enriched by keynotes from industry and academia, a captivating catwalk show, and a costume showcase from the students at the University of Huddersfield.

The theme of sustainability flowed into the Parliamentary lunch. It was truly wonderful to welcome friends and colleagues from around the globe to this prestigious gathering hosted by Lord Simon Haskel CompTI CText ATI. Karla Magruder of Accelerating Circularity shared her approaches to building circularity to ensure sustainable growth.

During my first term in office, the Honorary Officers and I have been working to develop a strategy that will see us through the next 5 years and beyond. This is an exciting opportunity to capitalise on our learning from the pandemic and build on the Institute's strengths. We have embarked on creating a set of global values and a vision statement that holds true to our mission, providing a framework to underpin our Royal Charter and to ensure financial sustainability to future-proof the organisation for the 21st century and beyond. This will enable us to serve our global community through our charitable status for the advancement of textile, clothing, footwear, and associated industries worldwide.

Our nine Sections worldwide and five special interest groups continue to support our service to the global community through a wide range of activities. Recently we have recently introduced a "Section showcase" to the Institutes Council meetings. We have been inspired by the Australian Section in October 2023 and the Sri Lanka section in January 2024. It was a real pleasure for the Section Chairs to share activities, events, and local discussions framed in an international context for Council members.

The Honorary Officers have been working closely with the CEO to ensure our business operations and governance are streamlined. We are delighted to announce that we are extending our TIIHQ family during the next year with administrative and marketing support.

Furthermore, I would like to take this opportunity to thank our staff who have worked tirelessly to support both myself, the Honorary Officers, and all TI members. The four core areas of business: publications, events, membership, and professional qualifications/awards continue to provide a steady income stream. Publications remain the main contributor for the Institute, and we value our continued relationship with Taylor & Francis, Elsevier, and CRC Press. During the next year, we are keen to expand our international Corporate Memberships to draw in new expertise from around the globe and to build on the successful short course programs which has seen substantial commercial interest in recent years.

During 2023 The Textile Institute's Executive Director became seriously ill and passed away early in 2024.

After a period of much uncertainty and recognising the future challenge, I remain cautiously optimistic for the future. There is much to be proud of and I am certainly looking forward to 2025, which will be a special year to mark the centenary of our Royal Charter. On a final note, Thank you for your continued support and dedication to The Textile Institute. Together, we can continue to make a significant impact on the textile, clothing, footwear, and associated industries worldwide.

Honorary Treasurer's Report

This is my first Honorary Treasurer's report covering a year which has been a very difficult one globally for the industry that we serve. Worldwide demand for textile products collapsed in 2023 in the face of rising interest rates, energy costs, the war in the Ukraine, political instability, and a general loss of consumer confidence.

It was an especially difficult year for the Institute exacerbated by the fact that for a significant part of the year, one of our senior executives and income generators was seriously ill and passed away in January 2024. This placed enormous, additional pressures on our already understaffed team at TIIHQ but once again they have risen to the challenge, and we can look back on the year with a modicum of satisfaction.

Once again publications were our major income stream in the year with another slight growth in royalties compared with 2022.

It was a difficult year for membership income and unfortunately, we saw no growth in either Corporate or Individual Membership. Given the general financial malaise affecting our industry during the year I think we were very fortunate to maintain the level of our Corporate Membership. Sadly, Individual Membership dropped marginally (4.4%) during the year, but this was not totally unexpected as some of the countries where our Individual Membership is strong were heavily impacted by very restrictive foreign exchange rules imposed by their governments. Collection of fees, both Corporate and Individual, was a major challenge in the year but I am happy to report that a major push in the final quarter has significantly reduced our overdue members list and had a beneficial impact on cash flow at a usually difficult time of year.

Without a bespoke course this year, overall short course income dropped by 13.6%, and income from the Parliamentary lunch was negatively impacted by external factors beyond the TIIHQ team's control, leading to a later than normal start to publicity. In both cases, I think the fall can be partially explained by the difficult financial climate and an industry focusing on cost control. In June, in collaboration with the University of Huddersfield, we hosted a successful Textile Institute World Conference which financially had a very positive impact on both income and cash flow for a relatively modest expenditure.

Although significantly below budget for the year, Professional Qualifications income almost doubled compared to 2022, despite the prolonged absence and illness of our TIIHQ member primarily responsible for generating income in this segment.

On the cost side of the equation, our team in Manchester are to be congratulated as once again they demonstrated their skills in cost containment and balancing expenditures against income to maintain a relatively healthy cash flow.

We have set some very ambitious financial targets for 2024, based around recruiting additional staff members at TIIHQ. This should improve the marketing of all our services and give our Chief Executive and her team the administrative support that will allow them collectively to increase both Corporate and Individual Membership, a major focus for 2024.

We have also begun implementing a culture change, and management information and control systems, which can form the foundations on which we believe a re-generation of the Institute can be built.

Professional Qualifications







Individual Qualifications

Since 1926 The Textile Institute has conferred professional qualifications to Individual Members. Members can apply by filling in an application form which is assessed by a committee of peers.

Licentiateship is awarded to those with a good level of knowledge in one specialist area and a general awareness of textiles and related industries. The holder of this qualification can use the post nominal letters LTI.

Associateship is a chartered professional qualification awarded to those with specialism in one area of textiles and a broad general knowledge of textiles and related industries. The holder of this qualification can use the post nominal letters CText ATI.

Fellowship is the highest level professional qualification awarded by The Textile Institute. Conferred to those who fulfil the requirements of CText ATI but have also made a major personal creative contribution. The holder of this qualification can use the post nominal letters CText FTI..

Accreditation

The TI accredits a wide range of courses worldwide to both Licentiateship and Associateship level. Students graduating from these courses are able to apply for their professional qualification after a shorter period of postgraduate work experience.

The courses are peer assessed and qualifying courses are able to demonstrate programme quality and excellence of provision.

Approval

The TI approves a number of courses globally through its Approval scheme. Designed for in-house training, short courses, on-line delivery and programmes not otherwise eligible for validation via the accreditation route. These courses can be approved with or without academic credit.

Submission is by application form and each course is assessed individually to ensure that the training offered is of the highest standard and supports the continual professional development of those working in textiles, clothing and footwear.

Sections

The Textile Institute is a fully international organisation represented by local and national offices around the world. Sections are run by its members who provide a programme of local activities, factory visits, workshops, seminars and social events.
